

Schedule "I"

The following are the Terms of Reference for the NHLLC:

Establishment and Continuance

• By no later than ninety (90) days after these terms of reference come into effect, the Company shall establish and maintain a community liaison committee to be known as the Newalta Hamilton Landfill Liaison Committee (NHLLC) that will be guided by the Terms of Reference as outlined below and applicable Conditions in this Certificate.

<u>Mandate</u>

- The mandate of the NHLLC is to:
 - (a) Facilitate communication between the Company and the community about the operation of the Site;
 - (b) Facilitate the addressing of community concerns about the operation of the Site.
- The mandate of the NHLLC may be fulfilled by way of the following:
 - (a) Providing a focal point for the dissemination and exchange of information relevant to the operation of the Site;
 - (b) Review, comment and make recommendations on the required operating and monitoring reports pertaining to the Site;
 - (c) Review, comment and make recommendations on applications for new or revised approvals pertaining to the Site;
 - (d) Review, comment and make recommendations toward the resolution of complaints and the addressing of issues relative to the Site submitted through the Company's complaint procedures; and
 - (e) Commenting and making recommendations on the structure and operation of the Company's complaints procedure.
- Changes to operation or mandate of this committee shall have the agreement of the Company, 2/3 of all voting members and the approval of the Regional Director of West Central Region of the Ministry of the Environment.

<u>Membership</u>

- Membership on the NHLLC shall be as follows:
 - A) Voting Members
 - a. There shall be four community representatives from the resident population of the City of Hamilton, with preference given to those who reside within 1500 metres of the Site. Should there be less than four community representative applicants, the NHLLC may operate with a minimum of two community representatives. The term of the community representatives on the NHLLC shall be the same as for the City of Hamilton representatives, four years. For the initial committee, the community representatives will be appointed for one, two, three and four years respectively to avoid complete turn over of membership at the end of four years.

- b. Two Representatives of the City of Hamilton appointed by the City of Hamilton, which representatives are not staff members. The term of the City of Hamilton representatives shall be for a four year term, to align with the terms of Council of the City of Hamilton.
- B) Non- Voting Members
 - a. There shall be one non-voting representative of the MOE on the NHLLC.
 - b. There shall be two non-voting members appointed by the Company on the NHLLC.

Operation of the NHLLC

- The NHLLC, on the occasion of the first meeting, shall elect a chair from the voting members of the NHLLC whose role it will be to call and preside over meetings of the committee.
- Selection of Community Representatives:
 - a. The procedure for the selection of the community representatives on the NHLLC shall consist of advertising for interested applicants in both a daily newspaper and a local community newspaper by the Company. Selection of the initial group of community representatives will be made by a selection committee comprised of the City of Hamilton, MOE and Company members. Subsequent selection will be conducted by the entire NHLLC, with input from both voting and non-voting members.
- Initial Meeting Procedures for NHLLC:
 - a. Meetings shall be held quarterly. Additional meetings shall be convened at the call of the Chair. All meetings will be open to observers from the public, with the exception of committee member selection, personnel matters and legal advice.
 - b. Meetings will be formal with an agenda circulated in advance of the meetings. Request for delegations to attend are to be made at least two days in advance of the meeting. Minutes will be taken.
 - c. Meeting dates, meeting agendas and meeting minutes shall be publicly accessible.

At the first meeting, the NHLLC shall set out additional general meeting rules and guidelines, including a quorum, procedures for voting, notice of meetings and procedures for open houses and public fora.

Funding for the NHLLC

• The Company shall provide funding, as required, to a maximum of \$10,000 annually for the reasonable costs of the operation of the NHLLC, excluding the costs of administrative services and quarterly meeting space which is to be provided by the Company at the Site. The NHLLC shall be responsible for preparing a budget and accounting for all monies spent. The budget and quarterly reports of monies spent shall be presented to the NHLLC. The \$10,000 amount shall be reviewed after one year and thereafter at a minimum of five (5) years. Request for funding for additional projects can be made to the Company. The Company will provide a rationale for all funding decisions on such requests.
